



St. Lawrence Catholic School 2023-2024 Financial Assistance Options

St. Lawrence Catholic School's administration, School Advisory Board, faculty, and staff intentionally strive to keep a St. Lawrence education affordable and accessible by charging less than the actual cost of education for all students. In addition to supporting a subsidized tuition model and controlling cost inflation for families, St. Lawrence Catholic School provides significant need-based financial aid. The following options are available:

1. Diocesan Catholic School Tuition Aid Grant (CSTAG)

The CSTAG award is assistance given by the Diocese to aid families with school tuition costs. CSTAG is available to all students who financially qualify and are registered at or have submitted an enrollment application to a Catholic school in the Diocese of St. Petersburg. Parents are required to fill out a FACTS Grant and Aid application for each new school year. **All applications must be submitted no later than April 15, 2023.** An FTC/FES scholarship may not be combined with a Diocesan CSTAG award.

2. Step Up for Students, Florida Tax Credit, & Family Empowerment

Household income level may determine eligibility for this scholarship & may be used at a Catholic school in the Diocese of St Petersburg. These scholarships are administered through the FTC & FE Scholarship programs. To apply, please visit: <http://www.stepupforstudents.org/logins>

NOTE: The FTC & FES scholarships may not be combined with a Diocesan CSTAG award.

3. Family Empowerment scholarship for students with unique abilities (FES-UA)

(Formerly known as the McKay & Gardiner Scholarships)

Students with special needs may qualify for the FES-UA Scholarship.

NOTE: St. Lawrence Catholic School is a direct pay school for the FES-UA. Families who receive this scholarship must make tuition payments to St. Lawrence Catholic School and seek reimbursement from the FES-UA Program.

4. St. Lawrence Catholic School Tuition Assistance Program

This is assistance provided to the school for families who do not qualify for the Florida Tax Credit & Family Empowerment scholarship, but still require a minimal amount of assistance with tuition. This scholarship is available to all students who financially qualify and are registered at or have submitted an enrollment application to St. Lawrence Catholic School.
