Through the **Parents Club Commit Program**, each family can select the option below that best meets their needs to reach the family's *minimum* service commitment to our school. Your service commitment is composed of two components: a financial component and a service component. Please read carefully before selecting an option.

By selecting Option A: Families are required to earn their service points and meet their financial commitment by the end of the school year. The financial commitment can be reached with little or no out-of-pocket expense through opportunities available such as Pot-O-Gold raffle sales. There will also be many opportunities to volunteer throughout the year with points being awarded at 1 point for each 2 hours served.

Families who select Option A that have not fulfilled their minimum financial and/or volunteer obligation will be invoiced the remaining balance at the end of the school year will be billed at the following rate:

- \$1 for each dollar not raised of the \$400 commitment (or \$200 for single parent)
- \$50 per point not served

IMPORTANT: If you select Option A and do not earn the required service points, you will be billed \$50 per unearned point. So, if you do not earn any points, you would be billed for 20 points at \$50 each totaling \$1,000 (or 10 points at \$50 each totaling \$500 for single parent families). This is in addition to being responsible for your \$400 financial commitment (\$200 for single parent families). *Note: Donating above your financial commitment through various fundraisers, will not count towards service point commitment.*

Responsibilities:

- Families are responsible for finding and participating in volunteer opportunities. These opportunities are available within x2VOL and will also be communicated in Parent's Club e-blasts.
- Families are responsible for tracking their service and financial commitments to ensure information is accurately reflected. Service commitment is tracked within x2VOL and financial commitment is tracked within FACTS (formerly Renweb).
- If extenuating circumstances prevent the family from reaching their service and/or financial commitments, the family is responsible for submitting a written request to the principal for consideration as soon as possible. Failure to submit this request in a timely manner (i.e., waiting until the last day of school) may result in the exception being denied. Extenuating circumstances will be reviewed on a case-by-case basis.

By selecting Option B: Families are *not required* to volunteer for events or participate in fundraisers. However, these families are welcomed and encouraged to volunteer, when possible, to help foster a stronger school community.
